### **Course Content**

The training consists of **15 modules**, each requiring approximately two days of effort. Participants can complete the entire course (15 modules) to earn a certificate or select individual modules of interest.

### **Topics include:**

- 1. Basics of EU insolvency law and practical applications.
- 2. Role of insolvency practitioners in restructuring proceedings.
- 3. Interim financing and transaction avoidance measures.
- 4. Handling essential contracts in insolvency.
- 5. Drafting and confirming restructuring plans.
- 6. Class formation and implementation in practice.
- 7. Employee protection in pre-insolvency situations.
- 8. Conversion of insolvency proceedings and work-outs.
- 9. Best interest of creditors test in practice.
- 10. Treating sanctioned enterprises in insolvency.
- 11. Insolvency practitioners' relationships with debtors and management.
- 12. Utilizing digital tools for insolvency practice.
- 13. GDPR application in insolvency practices.
- 14. Cross-border cooperation among insolvency practitioners.
- 15. Communication with stakeholders in international insolvency cases.

#### Each module includes:

- Introductory video.
- Main reading materials.
- Practical tasks and case studies.
- Final quiz for certification.

Participants will also have access to forums for discussions and sharing best practices, with regular updates from project experts.

## **Interactive Workshops**

Workshops will be conducted online (via Zoom) and facilitated by two experts. These sessions will:

- Start with a presentation on a specific topic.
- Include practical examples and case-solving guidance.
